Insurance for truck drivers in foreign countries

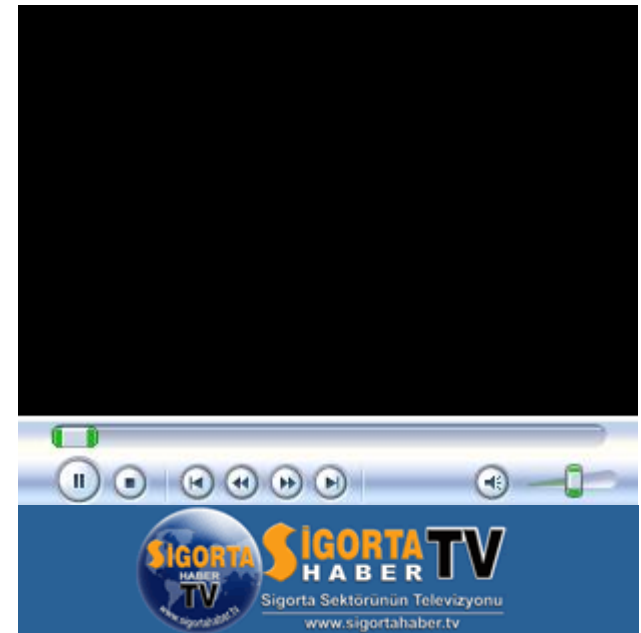

"Provision reaches 50,000 euro for single case" Telling that the provisions are extended on the "UND Travel Health" product, Evrim Sigorta Aracılık Hizmetleri Chairman Ismail Hakki Celebi "In this policy the provisions have been increased to 250,00 euro from 30,000 euro. I can tell that 'UND Travel Health' is the cheapest policy in the market taking into account that it has so large provisions.
